



Nonprofit Partner Program

Summit Leadership offers three Nonprofit Partnership levels: our Primary Partnership, our Plus Partnership, and our Premium Partnership. Summit Leadership's services at each level are designed to help nonprofits save money, attract volunteers, and increase funding for their organizations. Each level assumes agreement with Summit Leadership's vision, mission, and defining values.

Summit's Vision: *Creating a global collaborative network of Christ-centered, community-specific, relational hubs.*

Summit's Mission: *Serving communities around the world with the love of Jesus Christ by creating relational hubs for Connecting, Consulting, Coaching & Caring.*

Summit's Defining Values:

1. *Serve First: Always seek to take the lead in serving others.*
2. *Three Wins: Good for those we serve. Good for the community. Good for Summit.*
3. *Relational, Not Transactional: Serving through relationship instead of through contract.*
4. *Power of Connecting: Believers, as the branch, must be connected to Christ as the vine, so we seek to naturally connect the right people to the right resources to further His kingdom.*
5. *God Owns the Bakery: When God calls us, He supplies all that is needed.*
6. *All About the Harvest: Keeping the lasting, eternal & spiritual impact in mind with all we do.*

Nonprofit Partnership Levels:

1. Primary Partnership \$600 per year (or \$50 per month)

- Receive a platform for communicating with the public through the display and occasional distribution of brochures, flyers, and posters.
- Be identified on the Summit website with your company name and logo.
- Have access to all common areas at our facility for informal meetings or individual work.
- Eligible to reserve meeting space:
 - Small meeting rooms (up to 15 people) are available for up to eight (8) hours per month.
 - Large meeting rooms (up to 60 people) or additional small meeting rooms can be reserved for an additional contribution.
- Access to drinks and snacks on a self-serve donation basis.
- Invitations to free monthly events for all organization leaders.
- Access to Summit's Certified Biblical Counselor and our Christian Counseling Referral Network.
- Receive discounted partner pricing on Summit events and seminars.

2. Plus Partnership \$1,200 per year (\$100 per month)

Includes all the benefits of our Primary partnership **Plus**:

- Eligible to reserve meeting rooms (up to 60 people) for up to eight (8) hours per month. Largest room (up to 200 people) can be reserved for an additional contribution.
- Multiple rooms can be booked per meeting, when available; additional contribution may be required.
- Use of Summit's 14' box truck for up to four (4) hours per month.

3. Premium Partnership \$2,400 per year (\$200 per month)

Includes all the benefits of the Plus program with the added **Premium** of:

- Eligible to reserve small and large meeting rooms (up to 60 people) for a total of 24 hours per month. Largest room (up to 200 people) can be reserved, additional contribution may be required.
- Multiple rooms can be booked per meeting, when available; additional contribution may be required.
- Use of Summit's 14' box truck for a total of eight (8) hours per month.
- Receiving up to 4 hours per quarter of Leadership Development Coaching for staff and board members during regular business hours.

Note (for all levels): Additional contributions can be made for occasional facility use beyond the agreement level. All meeting space must be reserved at least 24 hours in advance and is scheduled on a "first come, first served" basis. Arrangements for basic room setup, supplies, and presentation equipment will be confirmed at booking. Outside catering is permissible. All rooms have wireless internet access.
