

## 2017 Non-profit Co-Op Partnership Programs and Services

Summit Leadership Foundation offers 3 levels of Co-Op Partnership: our Primary Co-Op Partnership, our Plus Co-Op Partnership, and our Premium Co-Op Partnership. Summit's services at each level are designed to help non-profits save money, attract volunteers and increase funding for their organization. Each level assumes agreement with Summit's vision/mission and defining values.

**Summit's Vision** *Creating a global collaborative network of Christ-centered, community-specific, relational hubs.*

**Summit's Mission:** *Serving communities around the world with the love of Jesus Christ by creating relational hubs for Connecting, Consulting, Coaching & Caring.*

### Summit's Defining Values:

1. Serve First *Always seek to take the lead in serving others.*
2. Three Wins *Good for those we serve. Good for the community. Good for Summit Leadership Foundation.*
3. Relational Not Transactional *Serving others through relationship instead of through contract.*
4. Power of Connecting *Believers, as the branch, must be connected to Christ as the vine so we seek to naturally connect the right people and the right resources to further His kingdom.*
5. God Owns the Bakery *When God calls us, He supplies all that is needed. Why worry about getting a piece of the pie?*
6. All About the Harvest *Always keeping the lasting eternal and spiritual impact in mind with all we do.*

### Features and Benefits of Co-op Partnership Levels:

1. **Primary Co-Op Partnership** \$500 per year (or \$50 per month)
  - Receive a platform for communicating to the public through the display and distribution of brochures, flyers and posters.
  - Be identified on the Summit website with your company name and logo.
  - Be invited to attend networking events at Summit including both non-profit and business partners.
  - Have access to all common areas at our facility for informal meetings or individual work.
  - Are eligible to reserve meeting space.  
Small meeting rooms are available for up to four (4) meetings per month (2 hours per meeting). Large meeting rooms or additional small meeting rooms would be at an additional per-use fee according to the space being used.
  - Have access to the Summit Hospitality Room (drinks/snacks available on a self-serve donation basis).
  - Invitations to free monthly **Grow Leader** workshops to all organization leaders.
  - Access to Summit's Licensed Professional Counselor and our Christian Counseling Referral Network.
  - Receive discounted pricing on local and national leadership events and seminars.
  - Enjoy access to the Quarterly Community Prayer Breakfasts hosted at Summit.

2. **Plus Co-op Partnership** \$1,000 per year (\$100 per month)

Includes all the benefits of our Primary partnership **Plus**:

- Eligibility of monthly large group meeting space (12 per year)
- Access to short-term storage space and package receiving services for UPS and FedEx shipments.
- Use of Summit's 16' box truck at no cost (driver must be approved).

3. **Premium Co-op Partnership** \$1,500 per year (\$150 per month)

Includes all the benefits of the "Plus" program with the added **Premium** of:

- Hosting two large group meetings *per month* (24 per year)
- Receiving up to 4 hours per quarter of Leadership Development Coaching for staff and board members during regular business hours.

**Note (for all levels):**

All meeting space must be reserved at least 24 hours in advance (including AV equipment) and is scheduled on a "first come, first served" basis. Meeting space can be used for training, fundraising, planning, etc. Summit staff and volunteers will be available to assist with room setup as requested and with administrative support such as making copies or providing hospitality services but we ask that a group representative arrive 30 minutes early to make any final adjustments. Outside catering is permissible. All rooms have Internet access. Projection equipment will be available as needed. Meeting supplies such as flip charts, notepads, pens, refreshments and beverages etc. will be provided on a low cost suggested donation basis for the actual amount used.

**Per-use Room Fees for Non-Profit Co-op Partners:**

Small Group meeting space (up to 6 people) - \$5 per hour (\$25 day max)  
 Medium Group meeting space (up to 25 people) - \$15 per hour (\$75 day max)  
 Larger Group meeting space (over 25 people) - \$20 per hour (\$100 day max)

**Additional "Fee for Service" Schedule (applies to all after hours and off-site services):**

\$60/hr. plus travel expenses // \$500/day plus travel expenses

Sliding scale for non-profits with annual budgets less than \$200,000

Less than \$50,000 annual budget	\$30 per hour
\$50,000 - \$100,000 annual budget	\$40 per hour
\$100,000 - \$200,000 annual budget	\$50 per hour
